

# **INDIAN TRIATHLON FEDERATION**

## **ELECTION PROCEDURE**

### **1. MANAGING COMMITTEE:**

The Officer Bearers and Managing Committee members of the Indian Triathlon Federation are:

President	-	1
Dy. President	-	1
Vice Presidents	-	7
General Secretary	-	1
Joint Secretaries	-	2
Hon. Treasurer	-	1
Managing Committee members	-	8

### **2. MANNER OF ELECTION:**

- i. Office Bearers and members of the Managing Committee of the Indian Triathlon Federation shall be elected by secret ballot.
- ii. Election shall be held at the Annual General Meeting (AGM) / Special General Meeting (SGM) in accordance with the procedure prescribed hereinafter, from amongst the representatives of the Permanent Member States / Union Territories.

### **3. ELECTORAL COLLEGE:**

- i. Each permanent Member State / Union Territory duly affiliated by ITF as its permanent Member shall have two votes at the Elections of the Office Bearers and Managing Committee members.
- ii. For the purpose of sub-clause (i), each permanent Member State / Union Territory shall be represented by two members authorized by the President or Secretary General or Secretary of the affiliated permanent Member State / Union Territory, however, in case President / Secretary General / Secretary nominates different person(s), the person(s) authorized by the President shall be deemed to be the duly authorized person(s), irrespective of the date.

#### **4. NOMINATION OF CANDIDATES:**

- i. The nomination of a candidate for election as Office Bearer or others to the Executive Council shall be made in Form 2 and whose name is there in Electoral College.
- ii. Each Nomination Paper Shall be delivered Personally to the Returning Officer in Person by the candidate himself/herself or by any authorized representative of the candidate.
- iii. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder and if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.

#### **5. WITHDRAWAL OF NOMINATIONS:**

- a. Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature in two days time.
- b. Notice of withdrawal of candidature shall be submitted in Form 5, either by the candidate himself/herself or by the authorized representative of the candidate.
- c. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- d. As soon as may be after withdrawal the Returning Officer shall prepare the final list of contesting candidates in Form 6, display a copy of the said list in his office and on Indian Triathlon Federation Website. And also furnish a copy of the same to each of the candidates/their authorised representatives, if they so demand.
